Micronutrient Pre-Mix

This product is a micronutrient pre-mix intended for further blending with organic soil inputs and fertilizers.

Guaranteed Analysis:

Zinc (Zn).....8%

Derived from: Zinc sulfate.

Nonplant Food Ingredients: sea water concentrate, humic acids, fish hydrolysate, molasses, worm castings.

Directions for Use:

Important: Use 50 mesh or larger screens on injection and spray nozzles.

This product is intended to be used to maintain micronutrient thresholds for crops, soils and forages as set forth in your Organic System Plan or as recommended by a soil testing laboratory to maintain soil fertility, ward off crop diseases and plant disease vectors 7 CFR §205.206(a)(3), to provide feed that is sufficient to meet the nutritional requirements of livestock § 205.238(a)(2) when feeds are consumed for their nutritional value.

It is recommended that you seek the advice of an agronomist to establish minimum plant tissue levels of micronutrients to ward off plant diseases and the advice of a livestock nutritionist to establish minimum levels of livestock feed micronutrients because feeds are the major source of micronutrients in our food chain.

Notice: Store above freezing (>32°F/0°C) and below 90°F (30°C). Once concentrate is added to spray or drip tank, apply solutions within 24 hours. This product can be tank mixed with most products. A bench test is strongly recommended.

Dilution: Dilute the following recommended amounts of product with 10-20 gal. of water. All Crops: 1-2 pints/acre

Plant micronutrient deficiencies are difficult to determine as their bioavailability is reduced by high levels of calcium, phosphorus and soil iron.
