Important: Use 50 mesh or larger screens on injection and spray nozzles.

Notice: Once concentrate is added to spray or drip tank, apply solution within 24 hours. Store above freezing (>32°F/0°C) and below 90°F/32°C. This product can be tank mixed with most products. A bench test is strongly recommended.

Intended Crops: Intended to be used on most fruit, vegetable, row crops and forages.

Dilution: Dilute the following recommended amounts of product with 20 gallons of water

Row Crops and Forages: 1-2 gallons/acre, 3-4 applications/year.

For Fruits and vegetables: Fertigate and/or foliar spray 2-4 quarts/acre every 5-7 days as needed.

Do not apply near water, storm drains or drainage ditches or to any impervious surface. Do not apply if heavy rain is expected. This product may only be applied to the intended application site.
